You are invited to submit an educational workshop proposal(s) for presentation at the symposium.

Proposals will be considered in the following practice areas related to minority populations:

- *Juvenile justice, foster care, criminal justice issues, trauma, diversity/cultural awareness, gender/sexuality issues, implicit bias, policy, advocacy, maternal mental health, violence and aggression, collaboration with law enforcement, accessing community mental health, as well as advocating for minority populations in the educational system.*
- **Ethical issues and ethical boundaries, and cultural awareness and diversity issues related minority mental health and any of the above areas are strongly encouraged.**

Presentations:

All presentations will be 60 minutes in length.

As part of the Request for Proposals application, prospective presenters will be asked to submit the following:

1. Presentation Description (2 pages maximum), which must include the following:

1. Presentation Title (Concise, interesting, memorable - 6 words or less)
2. No less than three learning objectives (Upon completion of this workshop, participants will be able to...)
3. Presentation Summary: Summary of your conference presentation that can be used on the conference website and in marketing materials (700 characters, approximately 100 words)
4. Sources/references of content (presenters are expected to include evidence-base and best-practice guidelines as appropriate)

5. Presentation narrative inclusive of topic to be presented, key points that will be addressed, and alignment with the conference theme/area of interest. (3,000 characters, approx. 500 words)
6. Name, including academic/professional credentials for each presenter, as it should be listed in conference related materials (example - James W. Smith, PhD, LPC)
7. A brief biography for each presenter for use in conference materials with an emphasis on relevance to presentation/conference theme (700 characters, approximately 100 words)
8. A resume or vita for each presenter.

Presenter Terms and Conditions:

In submitting a proposal, I understand that I am agreeing to the following on behalf of all individuals participating in this presentation:

- Presenter(s) must be available to participate in the conference at the time scheduled by the conference committee.
- All travel-related costs, including meals not included with the conference, lodging and airfare, are the responsibility of presenter(s). Symposium is in person. Presenter will receive an honorarium.
- Agreement to participate in the conference and grants permission for the presentation to be recorded (audio and/or video), photographed, and used in social media and other conference related summaries and promotion.
